

#### **Immediate result 2:**

Thanks to the establishment of the observatory, a clearer picture has emerged of changes, of the weaknesses and challenges of smallholdings, as has an assessment of the living standards of the farmers and the state of the smallholdings, plus the impact of national and regional development policies and programmes.



# Observatory of West African Smallholdings I- Context and justification

Several factors support the establishment of the observatory
☐ Smallholdings (SHs): main WA agricultural production system
☐ Huge contribution to feeding the population
☐ Create jobs and wealth
☐ Protect the environment  But SHs are misunderstood  Lack of understanding of SHs
□ Prejudice and anti-SH sentiment □ Lack of confidence in the SH's ability to feed the people, or to create wealth and jobs, etc.



## Observatory of West African Smallholdings II- Purpose and goals

#### **Purpose**

To improve the conditions of the SHs:

- by ensuring the professional development of their members;
- by creating genuine opportunities for development with a view to steering relevant national, regional and international policies in a direction which favours the development of the SHs.



## Observatory of West African Smallholdings II- Purpose and Goals

#### Goals

To boost the credibility of the Producer Organisation approach, plus that of PO networks in lobbying in favour of the SHs;



To help improve the conversion conditions of the SHs (more efficient, improving living standards with the SHs' wellbeing in mind);

To support the implementation of ECOWAP by developing a monitoring and alarm system;

To act as a consultancy support system for the benefit of the SHs.



### Observatory of West African Smallholdings <a href="mailto:lil-Guidelines">III- Guidelines</a>

- 1. Local roots: Based on the FCs (French-speaking countries) and the regional networks, and on what is already present in the sub-region to build the system;
- 2. Progress capacity: based on stakes but also the FCs' rates and capacities;
- 3. Subsidiarity: taking co-ordination levels into account (Local, national and regional);
- 4. Pooling: sharing key experiences and dynamics witnessed within the country;
- 5. Prioritising: selecting information on which to work on a consensual basis.



## Regional Observatory of WA Smallholdings IV- Structure and collection tools

Establishment of a national and regional committee including all the partners (Ministry of agriculture; statistics, research, universities, partner networks, NGOs, TFPs, etc.);
First set of FCs identified to render the SM observatory operational: Burkina, Mali, Niger, Senegal;
Data collection tools adopted

- 'Simplified balance sheet' maintenance guide;
- Questionnaire on smallholder organisations.
